CASA of Tulare County, have committed ourselves to gather our community to assist these children, our most vulnerable population and the future of our community. We are a non-profit organization and our entire focus is finding volunteers with the emotional strength, commitment, and compassion to care for our kids.

## 0-5 CASA's

From infancy to 5-years-old, a child forms their most basic learned understanding of the world around us. They learn to rely on the adults that care for them and this later teaches the child to trust and evaluate life a certain way. When our youngest ones to lack trust in adults, they fall victim to slowed developmental growth, increased acting out, and the inability to cope under pressure.

44% of the children appointed to CASA of Tulare County are between the ages of 0 and 5-years-old. When the judge appoints CASA to a case, it doesn't mean the child instantly has a CASA volunteer in their lives. Currently, 104 children from 0-5 are waitlisted for a CASA volunteer, nearly half of our entire waitlist of children from 0 to aging out of care!

Programs like the Child Find Campaign recently introduced to the Tulare County Office of Education/Special Education Local Planning Area, assist adult figures who care for our 0-5 population.

We all want to ensure that every child has the help they need, and children with special needs often need just a little more. "Child Find" helps to ensure every child with a disability has the help and support they need to grow and thrive. The program accepts referrals and screens children who may have a disability at no cost, and in turn refers the child to the necessary educational facility for evaluation and/or services.

A referral to Child Find may be made by a parent or by any person concerned about a child. Parent involvement and agreement is obtained prior to any further action. Information is confidential and the privacy of children and parents is protected.

If you know of a child who has one or more of the following disabilities (or you suspect a child has a disability) please let them know.

autism
blindness or vision impairment
deafness or hearing impairment
developmental disability (mental retardation)
learning disability
physical or orthopedic disability
speech/language difficulty

# **Family Connections**

(Please note: the names listed in this story have been changed for anonymity's sake, but the story itself is true nonetheless.)

We'd love to celebrate the story of Stephanie, a 13-year-old female who lost her mother when she was 4-years-old. Stephanie was moved and taken into the care of various family members until she ended up with her eldest sister, Jane, when she was 7-years-old. Unfortunately, this didn't last long, as the sister was young herself and felt it was only necessary to surrender her younger sister to the system that could hopefully better care for and protect Stephanie.

Jane, when speaking to the team, stated that she was caught off guard when Stephanie was placed in her care and noted that by the time Stephanie was in her teenage years, in her words, was "out of control." Jane felt she had no choice but to surrender her sister to the agency and reported that she was no longer able to care for her sister's needs.

Jane had no legal standing, but desired to see her sister cared for. Their mother had passed unexpectedly, leaving no legal guardianship in place. The case was referred to the Family Connections Program in hopes that the team could find lifelong connections with family members, and a support system that would be there for the youth for years to come.

In this case, the Family Connections Program was not only able to locate family outside of Stephanie and Jane's reach, but also assist in mending relationships once severed during their loved one's passing.

At this time, Stephanie has chosen to stay with her current resource parents while maintaining the connection created with her extended family. The resource parents are very supportive of the Famiily Connections Program. From the time this case started, our team has been able to connect the youth to her maternal grandmother, maternal aunt, 3 half siblings, and 4 cousins.

Stephanie is slowly beginning to understand the importance of having a support system, even when the possibility of being able to live with them is not an option. Family Connections will continue to work with the youth, Child Welfare Services, and the family to establish a plan that will help and support the youth during her time in Foster Care and thereafter.

We are thankful for our team's hardwork in securing Stephanie with a brighter future ahead filled with additional support!







When explaining that she wasn't going to be their CASA anymore, the kids didn't understand. She had to explain that it was a good thing because she felt they were in a good place and being well taken care of... but the oldest said, "it's just weird to hear you won't be our CASA anymore... even if we still see you or don't...

## 6-21 CASAs

Recently, Emily (name changed) had run away from home. Advocate Jennifer asked if she could send Emily a message directly, via Facebook, but for safety and anonymity purposes, it was decided the CASA should send the message on behalf of Jennifer.

Jennifer sent the message she'd wanted to send to Emily to CASA Staff and it said, "Hey Emily, it's Jennifer from CASA. I am very worried about you. Can you please let me know if you're okay or need anything. You can call me on my cell... email me... or message me back through this account. Please come back. Let's talk to your social worker about your placement in Porterville. I love you Emily and just know that I am here for you. -- Jennifer"

CASA staff sent the message to Emily's Facebook account and after running away on 09/04/19, Emily returned on 09/09/19, just 5 days later. Emily and her mother reached out to Jennifer via telephone and agreed to meet with Jennifer in Porterville. Jennifer proceeded to return Emily to care by first going to the Porterville Police Station and called the Child Abuse & Neglect hotline. An on call social worker picked up Emily and placed her in a resource home. We are happy to announce that Emily is safe and in proper care with Jennifer by her side!

Another case in which teamwork had a play, was with Joseph (name changed) who after being removed from his home the violin was left in his home, leaving the school with a missing instrument. The school then denied Joseph the opportunity to



continue in band until he had his instrument back or paid the cost of replacement.

After a thorough search through the home with social worker,

it was determined that the instrument was gone. The social worker reached out to CASA regarding this situation hoping to either have the instrument replaced or the fee paid to assist Joseph's desire to continue in band.

Our theme for the season is that it takes a community to raise a child. After reaching out to the Torres family from the Roox Agency, who also work with kids and music, Euler Torres was able to find a replacement violin from a donor, Grace Rios, in the community. The violin was received from Grace in Porterville and was delivered to the resource parent. Joseph is now able to continue his musical education as a result of a community effort!
